### **Draft Minutes of the kick-off meeting COST Action IC0702**

#### **Action IC0702: Combining Soft Computing Techniques and Statistical Methods to Improve Data Analysis Solutions Monday, March 31<sup>th</sup> 2008, Brussels**

#### **1. Welcome**

The participants of the inaugural meeting of COST Action IC0702 were welcomed by Dr. Maggio, the responsible Science Officer for the Action. The first part of the meeting was chaired by Dr. Maggio, including the election of a Chairperson for the Action, which was carried out under agenda item 8.

#### **2. Approval of agenda**

The draft agenda for the kick-off meeting was adopted (Annex 1).

#### **3. General information on COST mechanism and the Annual Grant Scheme**

The participants were informed about COST and the current situation in general and the COST Actions in the field of Information and Communication Technologies (ICT).
